

The title of the book is just straight misleading. I knew the Princeton Review tests weren't actual tests but I bought them anyway because I think any sort of preparation has value of its own. But the primary reason I bought this book was because it claimed to have 6 tests and not only two. In VERY

SMALL print (marketing ploy alert), they say that the 4 tests are online. I thought that was fine until I actually purchased the book and accessed these tests: you will NOT be able to print these tests. You literally have to take these 4 additional tests online with your mouse. Now THAT was disappointing. The LSAT is taken on print books and you use your pencil to mark the test (passages, diagrams, relationships). So it just makes absolutely no sense that I take an online test when most of my preparation (and the preparation that Princeton Review endorses) requires using a pencil. The book says that you should use your pencil and mark the test up and it gives you online tests making it impossible to practice their professed "higher score guaranteed" techniques. Way to go Princeton Review.

In small print you will see on the cover that the book only has 2 tests, with 4 online. That is garbage. Not to mention they are counterfeit tests. That is to say they are made LIKE real LSAT tests but not actual tests. I knew that part going in and heard these were harder and judging by my scores here they are compared to my higher actual LSAT scores Beware of this book.
